**LIZZIE:** My life has changed immensely since first coming to Brighton Center! I was in a very common situation (unfortunately it's a common situation). I was trapped in a very abusive relationship and started using drugs to try and cope and to feel less. He was in control, I could not see my family without permission because he knew they would try and talk some sense into me and he could lose me. I was allowed to go to family parties like Christmas if I was getting a cash gift from my grandpa. We did not have a permanent home.

I did a lot of things that I am ashamed of and I didn't care because it was my way out of reality not to feel physical pain, quilt, sadness, literally nothing. I was told it was too late, no one would ever love me because of the things I've done and he was the only one I have. He would hold me and show bits of love (which I craved), that's what kept me around and that's sad. Then, he had a jail stay that was longer than a week. That's when my family got me and thanks to them in March of 2011, I checked myself into Brighton Recovery Center. Those 15 months I spent there were the toughest (because I had to face myself and

forgive), the best (because of all the great people I met and the sisters I gained), rewarding (because I overcame that horrible situation, and the most life changing thing I've ever experienced. Not only do they help you stay physically clean, but they take the pile of rubble you have become and build you back up starting with a strong foundation of love and support.

The one memory that sticks out the most was the day I walked into Brighton Recovery Center. I did not have anything at all except a single bag of clothes and some toothpaste; I was as thin as a rail and probably shaking with fear. I remember everyone was smiling and joking with each other, everyone was so happy. I thought 'No one can truly be this happy, they are faking it. Quit smiling, don't smile at me. Why am I here? I don't need this; I can do this at home on my own.' This was a program that could last up to 18 months! But I knew if I walked away I would surely die. Everyone I surrounded myself with for the past three years hated me and controlled every single thing I did, every single decision. I didn't trust anyone and I didn't know how to do anything on my own. I had been closed off to the world for years so

this experience alone was terrifying, my anxiety was unbearable. But, the staff and residents at Brighton Recovery Center knew exactly what I was going through (staff being seniors in recovery) and they were there to help me overcome all that fear and old ways of thinking. And that's what

Today I can spend time with my kids and family, I can set a positive example and be a part of their lives. I actually have a life now, I have emotions, yes the past still comes to haunt me, and yes I do get sad, discouraged, I feel guilt. But I FEEL and I CHOOSE to deal with it differently today, I am forever grateful for Brighton Center and everything they do for the community and its

Nothing is impossible with a little support. There is help out there, no matter the situation so do not give up. I always suggest even if you don't need the help, everyone knows someone who does so check out Brighton Center and everything they have to offer. It is such an amazing organization!

Brighton Center, at its very core, is a community-based agency invested in creating a better place for the people who live and work in our region. The needs of the community are the driving force behind the work we do in engaging all residents from young children to older adults. Programs and services for youth aim to ensure they have positive outlets for growth, safety nets during a crisis or hard times, and a support system to navigate into adulthood. HOPE CHANGES EVERYTHING for residents and children of our community as they strive to achieve to their fullest potential.

**DEVRA:** I first became involved with Brightor Center when I moved into Homeward Bound, I was most impressed with the care and love the staff had for all the kids! Brighton Center turned my life around for the better and still to this day they support my choices and are there for me. Brighton has made a huge impact and it can be seen through all the men and women they have

They gave me an opportunity to be successful through Finanical Services in money management, and repairing and re-establishing credit. The staff also helped me get my first apartment! #### YOUTH LEADERSHIP DEVELOPMENT

The Youth Leadership Development (YLD) program is encouraging youth to be leaders in many ways. YLD provides structured activities and opportunities for youth to acquire and improve their life skills, decision making, and leadership skills. YLD uses the Wyman's Teen Outreach Program® [TOP®], designed to develop social and emotional well-being and mental health of pre-teens/teens. The TOP® approach provides youth with critical supports and opportunities to prepare for successful adulthood and avoid problem behaviors. Youth learn important skills such as communication skills/ assertiveness, understanding and clarifying values, relationships, goal-setting, influences, decision-making,

# **FAMILY CENTER**



Every child deserves access to high-quality educational experiences that ensure they are on track for success in school. Unfortunately, the reality is that many families struggle to provide quality early childhood experiences. However, HOPE CHANGES EVERYTHING for a child's future as they are given the supportive environment to reach important developmental milestones from birth through the start of kindergarten while also supporting parents in their role as their child's first teacher.

**GAIL:** I have been involved with Brighton Center since before my daughter was born. We moved to Kentucky when I was eight months pregnant and I heard about Every Child Succeeds. Our first meeting was supposed to happen on May 21, 2008, but when my home visitor called to confirm, my husband had to tell her that we would need to reschedule because I was in labor. On May 22, 2008 my beautiful little girl was born. After she was born we became part of Every Child Succeeds and then following graduation three years later, enrolled in Home Instruction for Parents of Preschool Youngsters (HIPPY).

The HIPPY program gave me tools and resources to help my daughter get a head start on her education. We received books that she still reads today and activities that built and enforced her new skills. My daughter gained skills with using her numbers and letters at an early age, and she gained a love of books that we share.

I have learned that there are always going to be people that want to tear you down, and there will always be people that want to build you up. I am grateful to have such supportive people in my life come from Brighton Center. They built me up to succeed even when I thought that I couldn't do it. When I didn't think I could go through anymore, I was given a hand to continue to move forward and keep looking for the good, and try to be the good

for other people.

Brighton Center provided the basics that we needed to survive when we could not provide them all for ourselves. The difference in our life is beyond measure. I don't know where my family would be without them. I have also been given the chance to give back in a small way to say thank you for the help I received. I am proud to do anything I can to help Brighton Center because it will have a lasting impact on the world my daughter will grow up in.

One of the biggest obstacles we have faced was when my daughter was two months old. We were told we could no longer stay where we were. We moved into a motel for a few weeks and then to a family friends house. Neither places were ideal but we were making do with what we had. With the help of Brighton Center we were given assistance for a deposit on a studio apartment, and a voucher to the Clothing Closet which allowed us to get clothes and blankets that helped us through the cold winter. We utilized the Food Pantry when we couldn't afford to buy groceries. We are now living in a two bedroom apartment in the Fort Thomas school district and are both employed. I am a fulltime student at NKU just beginning my second year. My daughter is a happy, healthy, beautiful little girl that knows nothing of the struggles we have gone through.

I worked with a Career Coach at Career Connections to seek flexible employment opportunities that allow me to earn the necessary income to support the household. I will also be starting at Brighton Center's Center for Employment Training where one of the kids is also currently enrolled.

I learned that I am not defined by my situation, that I am a worthy person, and that I can contribute to my life, my family, and my community. I am so proud to say that I am involved with Brighton Center. The staff have an amazing ability to help, yet also empower a person to feel they are important and can succeed. The programs at Brighton Center are "real life" programs that help you to become a better person, and help you sustain life, family, and community.

The path to financial stability often starts with a good education, starting a career, and managing finances. The reality though is that a bump or unexpected curve on that path can send a family into a downward spiral very quickly, but HOPE CHANGES EVERYTHING with the right support and guidance. Our Financial Services focus on educating, empowering, and supporting families as they take charge of their money by making smart, informed decisions.

TERESA: I first became involved with Brighton Center about 25 years ago in the early 90s. I lived across the street from Brighton Center's first location on 8th and Brighton Street. We utilized Emergency Assistance services to receive food and clothing. My two children also went to preschool at Bright Days Child Development Center.

I often volunteered watching kids while their parents attended the Center's parenting classes. I have volunteered in almost every department since then. My favorite volunteer memory is going to Kings Island with the kids.

In 2001, I started looking into homeownership

options. I worked on establishing credit, focused on budgeting, and looked at what I could realistically afford with help from Financial Services. I wanted to stay in Newport since it was always home. I loved how they were always there to talk to me. I attended a home ownership workshop and was able to save over \$15,000 for the down payment. I screamed with joy when I found out I was approved for a mortgage. After 18 months of hard work, I received the keys to my brand new three bedroom home just down the street from Brighton Center.

Throughout the process, I never gave up hope, and because of Brighton Center. I am now a homeowner and I have been at my job at the

Marriott Hotel for 18 years. I am more confident and I have a higher self-esteem now. I learned I can do anything I set my mind to. I was able to become self-sufficient and live within my means. I really enjoy running into people I haven't seen in five or six years who used to come to Brighton Center, and having them still remember my name.

Fellow volunteers and donors keep up the good work and when you are helping somebody out as long as you feel good in your heart you know you are doing something great. For anyone who needs assistance, I would say never give up because there is always someone at Brighton Center who can help.

"Thanks to all at Brighton Center, especially Brighton Center's financial counselors. You gave me hope and perseverance and helped me to see the light. The IDA program does work, just keep chipping away".

Rita is now a proud homeowner after saving money through her Individual Development Account. Individuals who participate in this program will save up to \$2,000 over a minimum of six months and when they complete their asset goal, will receive a 1:1 match of up to \$2,000, for a total of \$4,000 that may be used for purchasing a home or car, for owner occupied housing rehab, or for higher education.

Life as a single parent is often filled with barriers and tough choices but, HOPE CHANGES EVERYTHING for participants of Brighton Center's newest program who are on their way to to gaining long-term stability. The ultimate goal of Northern Kentucky Scholar House is a twogenerational approach that results in children receiving critical early childhood educational experiences that contribute to lifelong success and for parents to achieve a post-secondary education leading to stable employment and long-term self-sufficiency.

**SHIBA:** I was in a situation that was fight or flight. I decided to leave and fight for a better future for myself and two kids. A friend of mine in Cleveland offered to let me stay with her to start over. One day in 2014, during my lunch break from work. I decided it was time. I packed up the kids and started driving North from our home in the South. I got to Northern Kentucky, about five hours from my friend, when I received a call that staying with her was no longer an option. Suddenly, we were homeless and living in a hotel room. We ended up at Women's Crisis Center.

As I was being connected to services through Women's Crisis Center, I heard about Brighton Center's Center for Employment Training and enrolled in the Business and Computer Technologies skill division. I needed something to focus on other then my situation and I put 110% into it. After six months, I found a job and completed the course. While at CET, I overheard a staff member talking about Northern Kentucky Scholar House and said right then and there, 'sign me up, I am ready to go, where ever you are building it. I will be there!' When she told me

they had just broken ground, and were holding information sessions. I made sure to be the first one there. I would often stop by during construction just to ask if they were done yet.

I was finally able to move into a three bedroom apartment in September of 2015. Northern Kentucky Scholar House and Brighton Center are unique, there is nothing else like it. We now have stable housing and all the barriers that I had are removed. I can focus on everything I thought I would never get to. Going to college was not important to me in the past, but now I have the opportunity pursue my dreams. I am currently enrolled at Gateway Community and Technical College in Communications while also taking Public Relations classes at Northern Kentucky University. I plan on completing my Bachelor's Degree and possibly pursuing a Master's Degree.

I am so proud of my personal journey and where I came from. I can see my own growth with the help of Brighton Center. It's like I have a whole new life. The holistic wrap around services are amazing. From basic assistance with food and

clothing to everything in between. You can come in for one thing and end up getting more help then you ever imagined.

I now have the time to volunteer and spend my days giving back as much as I can. I often share my experience with other people and I enjoy seeing the work that goes into helping others from start to finish.

If you really want to stand on your own two feet. this is the place to do it. I came to Kentucky in 2014 with only clothing, the truck I drove, and my two small children. I was like a mouse in a maze looking for the next opened door. When I discovered Brighton Center, there were so many opportunities available all in one place. With their help, I was able to plant my feet on solid ground, and make my way back to independence. Brighton Center did something that not even my own family could do. They provided me and my family with direction and support that is unmatched. Saving that Brighton Center has enriched our lives is an understatement. I feel as though Brighton Center saved our lives.

Gaining employment with a livable wage and benefits is often one of the most challenging issues faced by individuals and families working toward self-sufficiency. Our region, like so many others, is experiencing a new reality in the job market. Certain career paths may no longer be viable options for employment, new skills sets may be required to become competitive, and a completely new career path is often a daunting reality to deal with, but HOPE CHANGES EVERYTHING. We create opportunities for people to thrive, by developing a strong workforce that has the education and skills to move our region forward. Our Workforce Development programs do exactly that.

**TAMMY:** As a teenager, if I wasn't running away from home, I was being kicked out. I had a lot of troubles and issues at home. I can remember my mother dropping me off at Homeward Bound. When I got a little older, I was emancipated from the state and got involved in another program within Brighton Center called the Independent Living Program. They taught me how to live on my own and I was able to leave the program and get my own apartment. From there, I experienced life, fell in love, and had my kids.

Everything seemed OK, but eventually I ended up getting a divorce because my marriage had failed. I went back to school and attended Gateway Community and Technical College along with Northern Kentucky University. I eventually earned my diploma in graphic design and became a graphic designer for 11 years until things started spiraling out of control. I couldn't pay my bills and I couldn't put food on the table for my kids.

So, I found myself once again turning to Brighton Center asking for help. They were able to provide emergency assistance through food from the food


pantry and assisted in helping me get my gas and electric back on. They also helped me pay rent for a month. That's when I learned about Brighton Center's Center for Employment Training. Brighton Center helped me get the training necessary to become a Medical Assistant. St. Elizabeth hired me on with a full-time job. I began working in the Diabetes and Endocrinology department. I was working with patients who I felt truly needed me. I was able to educate patients reassuring them that everything was going to be okay. It made me feel good to be able to help

I was then given the opportunity to learn more in the Oncology and Hematology department. I felt like I was making a difference by helping lift up cancer patients with a smile or a good joke or just by being there for them during a difficult time. Now, I am a registered pharmacy technician within at St. Elizabeth Healthcare making sure that cancer patients receive the appropriate medications and chemotherapy in the most efficient manner.

I've always wondered what my kids think of how I have done in life, but never really asked. One day, my son, who is 20 years old, said to me "well mom, the way I see it, it's like this - Brighton Center was your foundation. They helped you build this little cement block to help you build your house on, and you continued building until you built that house. Sometimes things fall off and you have to fix that part by going back to Brighton Center and learning how to do something else." He then said "but eventually, you take that house and you let your kids build their own foundation off of it." Him saying that blew me away. That let me know that he was really proud.

# FIFTY YEARS 1966 - 2016

From small grassroots beginnings to Northern Kentucky's most comprehensive social service agency.

Northern Kentucky's rivice agency.

50 years ago a movement of hope was started. A movement to create opportunities for individuals and families to achieve their hopes and dreams. A movement that has resulted in thousands of lives changed for the better with not only a long-standing support system, but also the tools, resources, and empowerment the residents of our region need to achieve self-sufficiency.

Brighton Center was founded in 1966, then known as Brighton Street Center, by Reverend Bill Neuroth as a summer recreation program for youth. At the time, a large number of families were migrating from rural Appalachia to the urban core of Newport for better living conditions and employment opportunities.

By late 1968, when Bob Brewster became Executive Director of the Center, services included Emergency Assistance, youth programming, and Community Organizing. Over the next 43 years, Bob Brewster moved the organization from a small community based agency to Northern Kentucky's most comprehensive social service agency. Over the years, programs and services were added in response to the needs of individuals and families looking to create a better life.

"The memory that stands out the most for me is when we made the decision to move services toward helping people achieve self-sufficiency. That was a total change in moving away from the dependency type relationship we had with the



Brighton Center has grown to serve tens of thousands of individuals and families each year from infants to older adults all across Northern Kentucky and beyond. Our comprehensive array of 41 programs and services allows for customers to receive individualized and bundled services based on their current situation and hopes for the future.

Our legacy is not only in our roots and our ability to evolve with changing times, but also in those who come to Brighton Center to create a better future. Hope Changes Everything!



As we look back to the beginning of Brighton Center, we are grateful to our early leaders and volunteers. One special group of volunteers was the Brighton Center Guild. Bob Brewster who was the first Executive Director of the Center made a request to local churches for volunteers. Many women from the community recognized the need and agreed to form the Brighton Center Guild. Within weeks the newly formed Brighton Street Center Guild began raising money, which along with a loan from American National Bank, helped finance the purchase of a building at 8th & Central. Renovation began immediately using volunteers and within six months agency programs were able to occupy the facility.

The Guild was the cornerstone of Brighton Center's mission for many years, leading the way for volunteerism and fundraising. The Guild was responsible for many fundraisers, but was most noted for its Lamplighter Ball. While the Guild is no longer active, several of these early leaders remain key volunteers today. One of these special people is Barb Manyet. Barb was a founding member of the Guild and served on this year's 50th Anniversary Gala Committee which raised a record-breaking \$167,000 for the agency.

Barb says "I love the Center so much that I will never give it up. I will always work with them and they will be tired of me before I am tired of them. Brighton Center shows you how to give to people, how to change their life, and how to do good as long as you can. I am inspired to keep supporting Brighton Center because of their model of self-sufficiency."

At the annual Community Celebration, the Family Center was dedicated and renamed the Bob and Helen Brewster Family Center. The Community Celebration has been part of our 50 year history offering families a fun afternoon with free food and activities.

**1966:** Rev. Bill Neuroth starts The Brighton Street Center located at 8th & Brighton Street where neighborhood summer recreation programs were offered for Newport youth.



**1967:** The Clothing Closet is established to assist those in need and the Brighton Street Center becomes incorporated.



**1968:** The Center grows to include Emergency Assistance and Community Organizing to respond to the needs of residents and the community. Bob Brewster becomes the first paid Executive Director and leads the organization for 43 years.



**1970:** The Board of Directors is formed and the Center receives critical United Way funding which has grown into 46 years of support and partnership. The first VISTA volunteers start and greatly increased capacity.



**1971:** The Guild forms as a volunteer and fundraising group establishing the Taster's Luncheon & Lamplighter Ball as their signature events. A VISTA volunteer starts the Center's first preschool program.



**1976:** The Center's commitment to Workforce Development and connecting customers to employment begins. Helen Brewster begins a long-standing tradition with the creation of the sewing class which continues until 2011.





**1979:** The Quilting Class is established with the purchase of 706 Park Avenue, further integrating the Center in the East End neighborhood.



**1980:** Our focus on housing and financial stability is established with the addition of housing research, counseling, and assistance services.



**1983:** Two Rivers Apartments for seniors and Homeward Bound Shelter for teens open and begin providing services to new populations for the



**1985:** The Brighton Street Center changes its name and becomes Brighton Center, Inc. Comprehensive services that focus on building trusting relationships with residents become the Center's



**1988:** The Center experiences growth and expands its commitment to youth through establishing Independent Living Services for youth. The "West End" building is constructed.



**1989:** Through a project with Newport Schools, a long standing collaboration is established through the creation of Family Resource Centers in Newport. The Northern Kentucky Law Center begins as a subsidiary, but in 1993 becomes a separate organization.






















































**2003:** The Center's focus on housing continues with the construction of Ann Street Commons which results in five homes built for homeownership in Newport's West End. The Family Center also completes construction.



**2005:** The importance of quality Early Childhood Education reaches a pivotal point in regional focus through the Newport Early Childhood Initiative, a Success by Six Collaborative. At the same time, Home Instruction for Parents of Preschool Youngsters is added as another service for parents and kids.



**2007:** Brighton Center helps form the Safety Net Alliance, a collaborative among churches and social services agencies to share resources and avoid duplication of services by working together to address common matters.



**2008:** The Brighton Recovery Center for Women opens which allows for a new population of customers dealing with addiction issues to become connected to services and programs.



**2009:** Brighton Center leads the Center for Financial Stability Task Force, a regional effort that eventually results in the Center's designation as a Financial Opportunity Center that bundles family and work supports, financial education, and workforce services.



**2010:** Agency restructuring leads to Financial Services becoming its own department which develops from over a decade of growth in providing financial education, coaching, credit building, and housing assistance to customers.



# A LOOK TOWARD THE FUTURE



Over our 50 year history, Brighton Center has led the way in providing innovative best practices that achieve results. Our commitment to working with families and communities to realized hopes and dreams continues into our next 50 years.

We will move into the future with lessons from leading and cutting edge approaches that support our strategic direction set through our community assessment process. Brighton Center's future will be influenced by the results of our involvement in key best practices. Two of these practices include Financial Opportunity Centers (FOCs) and 2Gen/Whole Family work.

During the past five years we have operated a Financial Opportunity Center (FOC) site in partnership with the Local Initiative Support Corporation (LISC). FOC's seek to improve low-income families' financial prospects by providing integrated employment assistance, financial coaching, and assistance accessing family and work supports to supplement income from work. An independent study by the Economic Mobility Corporation has found that customer's of Financial Opportunity Centers (FOCs) are more likely to be employed year-round, to reduce non-asset related debt, and to build

positive credit histories than comparison group participants. These findings offer concrete evidence that this model is successful in helping low-income people reach their financial goals and create a brighter future for their families. The evaluation was conducted as part of a grant from the Social Innovation Fund to implement evidence-based solutions. Our agency-wide FOC philosophy of service bundling will continue to strengthen agency impact.

The future of families rests in understanding and addressing the complex needs of the "whole family". When we support families holistically and reduce barriers, both children & parents will be more successful. Brighton Center has worked with national partners such as W. K. Kellogg Foundation, Ascend at the Aspen Institute, and the Anne E. Casey Foundation to deepen our 2Gen focus nationally and in the Northern Kentucky region. This focus will result in families realizing their dreams.




